## **DESCRIPTION**

ABA Abaprime Single Part Primer is a water-based primer used for improving the adhesion of ABA and ARDEX products to smooth, dense and various non porous substrates. It is easy to apply with a brush or roller with applications of subsequent products able to take place with minimal downtime.

ABA Abaprime Single Part Primer is suitable for internal and external wall or floor applications.

# **FOR USE WITH**

ABA Abaprime Single Part Primer is compatible with subsequent applications of ABA tile adhesives, floor levelling compounds and in non fully immersed conditions with ABA undertile waterproofing membranes.

# **TO (SUBSTRATES) FOR TILE ADHESIVES**

- Internal particleboard, plywood, sheet timber
- Medium density fibre-cement sheet, compressed fibre-cement sheet
- Jointing compound over plasterboard
- Concrete, renders, screeds
- Masonry and lightweight concrete blocks
- Autoclaved aerated concrete (AAC)
- Existing surface prepared glazed tiles (not suitable for shower floors or permanently immersed conditions).

# **TO (SUBSTRATES)** FOR FLOOR LEVELLERS

- Internal particleboard, plywood, sheet timber ARDITEX NA only
- Compressed fibre cement sheets
- · Concrete, masonry and lightweight concrete blocks
- Autoclave aerated concrete (AAC)
- Existing glazed tiles (tiles to be de-glazed before priming)

Note: Not suitable for steel trowelled finish concrete where flor leveller is being applied.

### **SUBSTRATE PREPARATION**

The surface to be primed must be clean, firm and free of dust, dirt, oil, grease, curing compounds, release agents and old surface coatings.

Ensure surfaces are dry prior to application, with no residue or permanent dampness.

Surfaces must be suitable for the application of the subsequent product being used.

#### **APPLICATION**

Stir product before use.

On floors, spread the material using a brush or long nap roller to cover at a rate of at least  $6\text{-}10\text{m}^2$  per litre over the entire surface to be primed.

For floor levelling topping application is highly absorbent substrates dilute ABA Abaprime Single Part Primer with water 1:1 by volume.

All tools should be cleaned with water immediately after use.

#### **DRYING TIME**

Ensure the ABA Abaprime Single Part Primer is fully dry prior to the application of subsequent products, allow approximately 20 minutes at 23°C and 50% relative humidity.

Type of substrate being primed, porosity and climatic conditions will affect drying times, allow longer for lower temperatures or high relative humidity.

## **COVERAGE**

One litre of ABA Abaprime Single Part Primer is sufficient for 6 - 10m², therefore the approximate coverage on each of the following units is: 1L per 6 - 10m² coverage will vary depending on the porosity of the surface and method of application.

#### **PACKAGING**

ABA Abaprime Single Part Primer is packed in plastic pails - net volume 1L and 4L  $\,$ 

## SHELF LIFE

ABA Abaprime Single Part Primer has a shelf life of 12 months when stored in the original unopened packaging, in a dry place at 23°C and 50% relative humidity.

Store away from direct sunlight. Replace lid tightly after use.

### Pay attention to the following:

Do not empty excess primer back into the original packaging as this may cause contamination of the contents. Do not use in negative hydrostatic pressure situations. Do not apply below 5°C or above 35°C.

# **SAFETY DATA**

Avoid contact with skin and eyes; in case of contact with the eyes, wash out immediately with fresh running water. If irritation continues, seek medical attention. Wear protective gloves, clothing and eye protection. Avoid inhaling dust/ fume/ gas/ mist/ vapours/ spray. Ensure adequate ventilation during mixing and application. Store locked up.
