



POTENTIAL HEALTH EFFECTS

### **ACUTE HEALTH EFFECTS**

#### **SWALLOWED**

The material has NOT been classified by EC Directives or other classification systems as "harmful by ingestion". This is because of the lack of corroborating animal or human evidence. • Metal-containing inorganic substances generally have negligible vapour pressure and are not expected to partition to air. Once released to surface waters and moist soils their fate depends on solubility and dissociation in water.
