Limitations on the use of the building product:	<p>The membrane and accessories are intended for use as a waterproofing system for the following roof and gutter substrates, cementitious timber.</p> <p>The system must be applied to a structurally sound, securely fastened and supported substrate. This will avoid substrate movement related cracking. The substrate should also be dry.</p> <p>Where the system is it to be used over a cementitious substrate, then the surface should be check for moisture content.</p> <p>Membrane must be protected from UV exposure long term.</p>
Design requirements that would support the use of the building product:	Waterproofing membrane for use in planter boxes, roof gardens and below grade application where there is a requirement for additional protection against vegetation roots.

Maintenance requirements:	No maintenance is required on the proviso significant building movement does not occur. Drainage systems must be maintained, with regular checking for blockages.
