

## FREE LEISTER® TRIAC AT HEAT GUN KIT WHEN YOU BUY 5 ROLLS OF ARDEX WPM 750 OR ARDEX WPM 1000 MEMBRANES - TERMS & CONDITIONS

1. Entry is open to customers who purchase five (5) rolls of ARDEX WPM 750 and/or ARDEX WPM 1000 from participating stores or direct from ARDEX New Zealand. Employees and immediate families of the 'Promoter' and 'Promotional Partners' are ineligible to enter. Persons must be over the age of 18 to enter.

2. The Promoter reserves the right to verify the validity of entries/claims and to disqualify any entrant who tampers with the entry/claims process or who submits an entry/ claim that is not in accordance with these Conditions of Entry.

6. Applies to non-discounted sales only of WPM750 (13319) or WPM 1000 (16475) to eligible customers, these are waterproofing customers or installers (reseller customers) purchasing through any reseller.

7. Offer only applies to full price purchases of WPM750 (13319) or WPM 1000 (16475), not purchases that have special project pricing, price discounts or special pricing of any form.

8. Products are specifically 13319 and 16475 not special sized products, made to order products or other ARDEX membrane products

10. Guns may be delivered in individual deliveries depending on stock availability. Delivery of guns to be completed by 30 April 2023.

11. Promoters' decision is final, and no correspondence will be entered into.

12. Any costs in excess of the value of the Prizes (if applicable), including GST, and all ancillary costs associated with redeeming the prizes are the responsibility of the winner.
